GENERAL CONDITIONS FOR THE HIRING OF MUSICAL INSTRUMENTS

Definitions

- a) The 'Owner' is Excel Music Schools Limited and includes its successors, assignees or personal representatives.
- b) The 'Hirer' is the school, parent/guardian or pupil taking the Owner's Musical Instruments on hire and includes their successors or personal representatives
- c) 'Musical Instruments' covers all classes of musical instruments which the Owner agrees to hire to the Hirer and includes any case or accessory provided with it.
- d) A 'Basic Period of Hire' shall be 12 weeks or one complete school term whichever is the longer.

Extent of Contract

No conditions or warranty other than herein specifically set forth shall be implied or deemed to be incorporated in or to form part of the contract

Availability

Musical Instruments are offered subject to being available to the Owner at the time required by the Hirer

Supply in Good Order

The Hirer must satisfy himself that the Musical Instruments are in good order and that any damage to the Musical Instruments is agreed before signing this agreement

Maintenance

- a) The Hirer shall be responsible for the safe-keeping of the Musical Instruments and ensure their use is always as agreed with the Owner.
- b) The Hirer shall take all reasonable steps to maintain the Musical Instruments in accordance with instructions issued and will promptly report any malfunction or accidental damage to the Musical Instruments to the Owner.
- c) No chargeable repairs are to be undertaken by the Hirer without the prior express approval of the Owner.
- d) The Hirer shall regularly clean the Musical Instruments and return same in a clean condition.
- e) The Hirer shall be responsible for any expense in connection with repairs, damage or cleaning of the Musical Instruments fair wear and tear excepted.
- f) In the event that it becomes necessary to remove the Musical Instruments from the Hirer for repairs the Owner will make reasonable efforts to provide a replacement. However where this results from the negligence of the Hirer an additional charge will be made for the replacements.

Consequential Loss

The Owner accepts no liability or responsibility for any consequential loss or damage due to or arising from the breakdown of the Musical Instruments through any cause whatsoever or through non-provision of the Musical Instruments arising from accident or breakdown.

Basis of Charging

- a) Musical Instruments shall be hired out for a minimum of the Basic Period of Hire.
- b) In all cases the Hirer must give notice of at least a Basic Period of Hire of their intention to return the Musical Instruments.
- c) All hire charges are payable in advance and are due on the first day of the Basic Period of Hire and must be paid within 14 days of that date or the hire may be immediately terminated. In this case the charge for the Basic Period of Hire will still be due.
- d) Consumable supplies eg. reeds are to be provided at the expense of the Hirer.
- e) A refundable deposit will be charged upon the signing of this agreement. Any unpaid hire charges or unrecovered repair costs will be deducted from this sum before refund.

Other Charges

Upon termination of the hire all Musical Instruments must be delivered to the Owner at either the place at which the initial hire took place or the registered office of the Owner. Any expenses incurred by the Owner in delivery or recovery of the Musical Instruments will be charged to the Hirer. Musical Instruments not returned at the agreed date or damaged beyond economical repair will be charged to the Hirer at the manufacturer's current published list price for the specific instrument or one which is similar.

Other Matters

The Hirer shall not sub-let or lend the Musical Instruments to any third party without first receiving the written permission of the Owner. The Hirer shall not use the Musical Instruments for any other purpose than that agreed with the Owner and specifically should not be used for commercial gain.
